

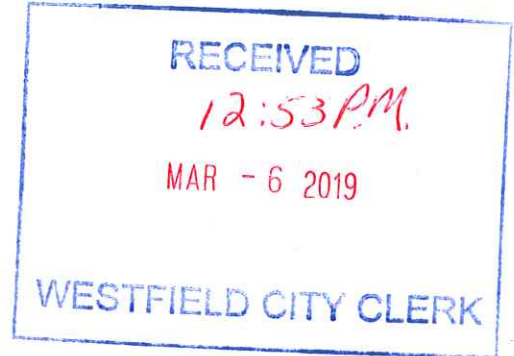

- I. Call to Order and Roll Call
 - a. Chair DiStefano called to order at 6:02 PM
 - b. Present: DiStefano Goncalves Hallberg Metsch Moorhouse Murray Ogulewicz Spruell
 - c. Absent: Spalding
- II. Public Speak Out (15 minutes)
 - a. No members of the public requested to speak
- III. Approval of minutes from January 10, 2019
 - a. Hallberg moves to accept minutes; Metsch seconds; passes unanimously
- IV. Chair report
 - a. DiStefano is serving on the Women's Fund advisory committee related to their data report on the Status of Women.
 - i. Committee is currently looking for data sources that the Fund can use in their report. If commissioners have any suggestions for resources, forward to Distefano to pass on.
 - ii. Report is scheduled to be published April 2
 - b. DiStefano attended the Human Trafficking Forum meeting and distributed contact information for speakers.
 - i. Businesses against human trafficking committee continues to train business staff.
 - ii. Attorney General announced a labor trafficking webinar that will take place Wednesday, Feb. 13 @ 10:30-11:30
 - c. Springfield Museums have a group called Women at Work, and they have an exhibit of the Women at Work exhibit and a women and art exhibit.
 - i. DiStefano inquired with the museums if they would be open to hosting a public hearing to take place sometime during the exhibit.
 - d. DiStefano reported on a follow up conversation related to the Berkshire County Commission on the Status of Women and Girls' previous request to host a public hearing in the Chicopee Women's Jail.

- i. NEPR has a series of reports on women in Berkshire County dealing with a “long distance lock up” in the Berkshire Eagle.
- ii. An Assistant Superintendent at Chicopee jail spoke with DiStefano and agreed to provide data related to questions that were raised about location.
- iii. Assistant Superintendent is also willing to speak at a future HCCSWG hearing.
- iv. The after-incarceration facility may be an option for a public hearing.
- v. Berkshire Commission raised visitation concerns related to distance as a major concern. However, statistically, women receive fewer visitors, so more data is needed to better understand the concern.

e. Moorhouse moves to accept chair report; Hallberg seconds; passes unanimously

V. Vice Chair report

a. Vice Chair was absent but sent a report electronically

- i. Senate has until April to sign on to bills, so advocates are asking for sponsorship now. We may not hear about specific group sponsorship until April as well.
- ii. It may be most advantageous to ask local reps what they are advocating for.

b. Ogulewicz moves to accept vice chair report; Metsch seconds; passes unanimously.

a. Constituent/Community Survey

- i. Preliminary data was presented
